Mr. MICHAEL F. DOYLE of Pennsylvania (for himself, Mr. JOHNSON of Ohio, Ms. MATSUI, and Mr. GIANFORTE) introduced the following bill; which was referred to the Committee on _____

A BILL

To amend the Communications Act of 1934 to provide for an auction of C-Band spectrum, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Clearing Broad Air-
5 waves for New Deployment Act” or the “C-BAND Act”.

1 **SEC. 2. AUCTION OF C-BAND SPECTRUM.**

2 Title III of the Communications Act of 1934 (47
3 U.S.C. 301 et seq.) is amended by adding at the end the
4 following:

5 **“PART V—C-BAND SPECTRUM**

6 **“SEC. 399L. AUCTION OF C-BAND SPECTRUM.**

7 “Not later than September 30, 2022, the Commission
8 shall—

9 “(1) clear and reallocate no less than 200
10 megahertz and no more than 300 megahertz of con-
11 tiguous C-Band spectrum (reserving 20 megahertz
12 as guard band)—

13 “(A) for the provision of broadband inter-
14 net access service; and

15 “(B) in such a way that ensures that C-
16 Band-dependent users—

17 “(i) receive equal or better service as
18 before the implementation of this section;
19 and

20 “(ii) receive such service continuously
21 throughout the transition process; and

22 “(2) through a system of competitive bidding
23 under section 309(j), assign licenses for the use of
24 the spectrum reallocated under paragraph (1), ex-
25 cept for the spectrum reserved as guard band.

1 **“SEC. 399M. DEFINITIONS.**

2 “In this part:

3 “(1) C-BAND-DEPENDENT USER.—The term ‘C-
4 Band-dependent user’ means a person who—

5 “(A) is a licensee or registrant of an earth
6 station receiving signals over C-Band spectrum;

7 or

8 “(B) receives or distributes programming
9 or services using C-Band spectrum.

10 “(2) C-BAND SPECTRUM.—The term ‘C-Band
11 spectrum’ means electromagnetic spectrum between
12 the frequencies of 3700 megahertz and 4200 mega-
13 hertz, inclusive.

14 “(3) CLEAR.—The term ‘clear’ means, with re-
15 spect to C-Band spectrum, to make such spectrum
16 available for reallocation and the assignment of li-
17 censes through a system of competitive bidding (or
18 reservation as guard band) under section 399L.”.
