SUBCOMMITTEE ON ENVIRONMENT AND CLIMATE CHANGE
VIRTUAL MARKUP

WEDNESDAY, JUNE 16, 2021

The Subcommittee on Environment and Climate Change of the Committee on Energy and Commerce met, pursuant to notice, at 10:32 a.m., a quorum being present, for a virtual markup on the Committee's WebEx platform, Hon. Paul Tonko (Chairman of the subcommittee) presiding. The business before the Subcommittee was consideration and markup of three bills. The following actions were taken:

1. [H.R. 3291](#), the "Assistance, Quality, and Affordability Act of 2021", was ordered reported favorably to the full Committee, **amended**, by a roll call vote: 14-9 ([ECC Roll Call No. 3](#)). (**Final Passage**).

The following amendments were offered during consideration of H.R. 3291:

- **An Amendment in the nature of a substitute (AINS) #1 ([AQUASCANS_01](#))**, offered by Mr. Tonko, was agreed to by a voice vote.
- **Amendment to the Tonko AINS #1a ([AMDT2HR3291](#))**, offered by Ms. Rodgers, was defeated by a roll call vote: 8-14 ([ECC Roll Call No. 01](#)).
- **Amendment to the Tonko AINS #1b ([AMDT4HR3291](#))**, offered by Mr. McKinley, was defeated by a roll call vote: 8-14 ([ECC Roll Call No. 02](#)).
- **Amendment to the Tonko AINS #1c ([CLARKE_01](#))**, offered by Ms. Clarke, was agreed to by a voice vote.

2. [H.R. 3293](#), the "Low-Income Water Customer Assistance Programs Act of 2021", was ordered reported favorably to the full Committee, **amended**, by a voice vote. (**Final Passage**).

The following amendments were offered during consideration of H.R. 3293:

- **An Amendment in the nature of a substitute (AINS) #1 ([LIWCAPSCANS_01](#))**, offered by Ms. Blunt Rochester, was agreed to by a voice vote.
- **Amendment to the Blunt Rochester AINS #1a ([3293SC_01](#))**, offered by Mr. Duncan, was withdrawn.

3. [H.R. 2467](#), the "PFAS Action Act of 2021", was ordered reported favorably to the full Committee, **without amendment**, by a roll call vote: 16-7 ([ECC Roll Call No. 04](#)). (**Final Passage**).
