A BILL

To amend the Public Health Service Act to authorize the Secretary of Health and Human Services to designate an officer within the Department of Health and Human Services as having primary responsibility for the information security (including cybersecurity) programs of the Department, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “HHS Cybersecurity
3 Modernization Act”.

4 **SEC. 2. INFORMATION SECURITY.**

5 (a) **AUTHORITY TO DESIGNATE CHIEF INFORMA-**
6 **TION SECURITY OFFICER.**—Title II of the Public Health
7 Service Act is amended by inserting after section 229 of
8 such Act (42 U.S.C. 237a) the following:

9 **“SEC. 229A. AUTHORITY TO DESIGNATE CHIEF INFORMA-**
10 **TION SECURITY OFFICER.**

11 “Notwithstanding any other provision of law—

12 “(1) the Secretary may designate an officer
13 within the Department as having primary responsi-
14 bility for the information security (including cyberse-
15 curity) programs of the Department;

16 “(2) any such designated officer shall report di-
17 rectly to the Secretary or directly to another senior
18 officer within the Department of the Secretary’s
19 choosing; and

20 “(3) the Secretary may transfer the functions,
21 personnel, assets, and liabilities of the Chief Infor-
22 mation Security Officer in the Office of the Chief In-
23 formation Officer of the Department of Health and
24 Human Services, as such position exists on Sep-
25 tember 30, 2017, to such designated officer.”.

26 (b) **REPORT.**—

1 (1) IN GENERAL.—Not later than 1 year after
2 the date of enactment of this Act, the Secretary of
3 Health and Human Services shall develop and sub-
4 mit to the Committee on Energy and Commerce of
5 the House of Representatives and the Committee on
6 Health, Education, Labor, and Pensions of the Sen-
7 ate a plan on the role of the Department of Health
8 and Human Services (in this subsection referred to
9 as the “Department”) in preparing for and respond-
10 ing to cybersecurity threats.

11 (2) CONTENTS.—The plan under paragraph (1)
12 shall—

13 (A) differentiate between—

14 (i) the responsibilities of the Depart-
15 ment overall and each of its agencies and
16 offices in maintaining the security and in-
17 tegrity of their respective information sys-
18 tems; and

19 (ii) the responsibilities of the Depart-
20 ment overall and each of its agencies and
21 offices in regulating and providing guid-
22 ance, information, education, training, and
23 assistance to the health care sector;

24 (B) specify how the Department overall
25 and each of its agencies and offices delineates

1 between the responsibilities described in sub-
2 paragraph (A)(i) and those described in sub-
3 paragraph (A)(ii) through organization, per-
4 sonnel, policies, and procedures;

5 (C) address the coordination of the respon-
6 sibilities described in subparagraph (A)(i) and
7 those described in subparagraph (A)(ii) across
8 the agencies and offices of the Department;

9 (D) address any types of conflicts that can
10 arise (within the Department or the health care
11 sector) because of the Department having both
12 the responsibilities described in subparagraph
13 (A)(i) and those described in subparagraph
14 (A)(ii);

15 (E) differentiate between—

16 (i) the role of the Department in reg-
17 ulating the health care sector; and

18 (ii) the role of the Department as a
19 Sector-Specific Agency for the health care
20 sector under Presidential Policy Directive
21 21 (signed on February 12, 2013); and

22 (F) specify how the Department delineates
23 between the role described in subparagraph
24 (E)(i) and the role described in subparagraph

1 (E)(ii) through organization, personnel, policies,
2 and procedures.

3 (c) NO ADDITIONAL APPROPRIATIONS AUTHOR-
4 IZED.—No additional funds are authorized to be appro-
5 priated to carry out this Act, or the amendments made
6 by this Act. This Act, and the amendments made by this
7 Act, shall be carried out using amounts otherwise author-
8 ized or appropriated.
